INVITATION TO BID (2ND POSTING)

PROCUREMENT OF ONE (1) MOTOR VEHICLE, PASSENGER VAN, WITH ENGINE DISPLACEMENT OF AT LEAST 1,950 CC, DIESEL ENGINE, FOR OFFICIAL USE OF THE PHILIPPINE EMBASSY IN BRUSSELS

The Philippine Embassy in Brussels, through the authorized appropriations under the General Appropriations Act, intends to apply the sum of EURO **Eighty-One Thousand** (€81,000.00) only, being the Approved Budget for the Contract (ABC) for the "Procurement of one (1) motor vehicle, passenger van, with engine displacement of at least 1,950 cc, diesel engine, for official use of the Philippine Embassy in Brussels." Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion pursuant to the guidelines of the Implementing Rules and Regulations (IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act" and Annex "A" of the Government Procurement Policy Board (GPBB) Resolution No. 28-2017.
3. Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

5. Bids must be received by the Bids and Awards Committee of the Philippine Embassy on or before 12:00 nn, 02 April 2024, Tuesday. Bid opening shall be held on the same date at 3:00 p.m. in the presence of the Bidder's representatives who choose to attend at the address above-specified. Late bids shall not be accepted.
6. The Philippine Embassy in Brussels reserves the right to accept or reject any bid, to annul the bidding process, and to reject bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
